#### 4. About the TMD

This Target Market Determination (TMD) document is not intended to provide financial advice. Please refer to our Terms and Conditions and Credit Guide before deciding product suitability. Our product terms and conditions will be provided to you upon request.

This TMD aims to provide an understanding of the class of customers we have designed this product for, being the target market. When considering the target market, we focused on our customers' objectives, financial situation, and needs within this class of people we believe this product to be suitable.

### 5. Target Market

### 5.1 Description of target market

The features of this product have been assessed as meeting the likely objectives, financial situation and needs of consumers who:

- are:
  - o at least 18 years old;
  - o individual borrowers (as single or joint borrowers); and
  - o an Australian citizen or a permanent Australian resident;
- require a loan to purchase or refinance a commercial investment property as part of a Self Managed Super Fund (SMSF);
- require an offset account;
- require the flexibility of a variable interest rate;
- require the ability to make additional extra repayments without penalty; and
- want the option of either principal and interest or interest only repayments.
- satisfy our eligibility criteria.



#### for SMSF Commercial – Investment Variable

Although variable interest rates fluctuate, the product meets the likely objectives, financial situation and needs of consumers in the target market because it allows them to deposit funds into an offset account and/or make additional payments directly into the loan to reduce the amount of interest payable whilst maintaining the ability to draw on surplus funds when required. This product also allows consumers to select interest only or principal and interest repayments in order to reduce their overall debt and build equity.

#### 5.2 Classes of consumers for who the product may not be suitable

This product may not be suitable for consumers who:

- do not meet the eligibility requirements;
- are seeking the certainty of fixed repayments over the term of the loan;
- are looking to purchase or refinance of an existing SMSF loan;
- are looking to construct a property; or
- require the ability to provide alternative methods of income verification.

#### 5.3 Description of the Product, including key attributes

- Variable interest rate;
- Repayment options:
  - principal and interest only;
- Redraw available
- Minimum loan size: \$50,000
- Maximum Loan Size: \$2,000,000 (subject to LVR and postcode policy)
- Maximum LVR:
  - o 70% for Inner-City postcodes
  - o 60% for Regional postcodes
  - 80% for Metro and Non-Metro postcodes
- Offset facility available for a fee of 0.3% pa added to rate
- Interest Only fee of 0.3% pa rate loader
- Commercial loader of 0.8% pa added to carded residential rates
- Application fee is nil
- Legal documentation fee is payable of \$770 for standard purchase and refinance, or \$990 for a rapid refinance settlement
- Valuation fee is payable at cost
- Ongoing fee is payable of \$395 per annum

#### 6. Distribution Conditions/ Restrictions

The following distribution channels and conditions have been assessed as being appropriate to direct the distribution of the product to the target market:

The distribution channels and conditions are appropriate because:

- the product has a wide target market;
- our staff have the necessary training, knowledge and accreditation (if required) to assess whether the consumer is within the target market. All of our staff must continually satisfy annual compliance reviews.
- we rely on existing distributors, methods, controls and supervision already in place;
- our approval system has checks and controls in place to flag applicants who may be outside the target market; and
- accredited mortgage brokers are subject to a higher duty under BID to ensure that the product is in the best interests of the particular consumer.
